#### **EXECUTIVE SUMMARY**

Education Sector has two directorates namely Education and Vocational Training. The Directorates are supervised by the Directors at the County Level and Sub-County Officers at Sub-County Level. The role of the sector is to provide quality pre-primary education and to impart technical skills and appropriate science and technology to youth trainees.

The Sector Report is guided by County Integrated Development Plan (CIDP) 2018-2022, The Department Annual Development Plan 2021, Kenya Vision 2030, training in the Department is aligned to Big Four Agenda, Governor's Manifesto and the Governors executive order of 2018 that moved Vocational Training from Youth, Culture, Sports and Social Services to the department of Education, ICT & e-Government. The report has highlighted performances and achievement of the sector during 2018/19-2020/21 showing the funding levels and the impact of the projects. Our priorities are based on quality pre-primary education and vocational training. The priorities outlined in the CIDP, Medium Term Plan (MTP) and Vision 2030 guide the development of the sector's priorities, policies, plans, monitoring and assessment resources for FY 2022/23-2024/25 MTEF budget, hence the sector has ensured that this report gives priority to areas that support education and training. The funds were utilised in various planned programs and projects

The vision of the sector is a globally competitive education, training, research and innovation for sustainable development with a mission to provide, promote and coordinate quality education and training. Our mandate is drawn from the Constitution of Kenya 2010, Schedule 4, Part 9 on the County Government functions. The report identifies both government and non-governmental stakeholders.

In the performance review 2018/2019-2020/2021 the report captures achievements in disbursement of County Bursaries amounting to Ksh. 334Million benefiting 87,512 Students in the year, construction of 509 ECD classrooms,

provision of instructional materials to all 940 public ECD centres, employment of 372 ECD Teachers and rehabilitation of Vocational Training Centres and disbursement of Subsidized Vocational Training Centre Support Grant to County VTC's, amounting to Kshs. 210M benefitting 12,045 trainees in the year under review. Construction of 6 VTC's and 4 Administration Block were done during the year under review. 75 VTC's were provided with tools and equipment and 35 instructors were employed. The report gives projections for medium term priorities and financial plans for 2022/2023-2024/2025 for the promotion of ECE, issue of bursary and revitalisation of VTCs. The sector depends on allocations from the county treasury for funding of all its projects. Cross sector linkages and intra sector linkages have been identified between the sector and other county departments and agencies.

The report also captures the challenges facing the sector which include inadequate funding, inadequate staffing, inadequate equipment, dilapidated institutional facilities, negative public attitude towards Vocational Training and delay in release of funds from the National Treasury.

Emerging issues experienced include COVID-19 pandemic, implementation of new pre-primary policy 2017, implementation of new Competency Based Curriculum (CBC) in Pre-Primary, implementation of Competency Based Education and Training(CBET), Government Policy on 100% transition rate to secondary schools, the National Government requirement that for a county to benefit from the Subsidized Vocational Training Support Grant the county must allocate in its budget funds matching a shilling for a shilling.

For the Department to achieve its target the ideal Gross Recurrent requirement for the period 2022/23 is Kshs. 1,050,297,946 against a ceiling of Kshs. 714,305,807, for the period 2023/2024 the Gross Recurrent requirement is Kshs. 1,266,492,361 against an allocation of Kshs. 788,736,387 and Kshs. 1,539,124,421 as the Gross Recurrent requirement against an allocation of Kshs. 864,310,025 for the period 2024/2025.

The priorities of the Sector include equipping ECE Centres with furniture and outdoor play equipment, establishing vocational training and pre-primary centres of excellence in every Sub-County, providing ECE teachers to all public ECE Centres and instructors in public VTCs. The sector emphasizes expenditure based on demand driven programmes that impact on people's livelihood. The role of stakeholders will be key to this sector in terms of provision of resources, monitoring and evaluation of sector projects. The report contains lessons learnt and recommendations for addressing the gaps identified.

#### CHAPTER ONE

#### 1.0 INTRODUCTION

### 1.1 Background

Education is a vital part of a society's growth and progress. Nakuru county government recognizes Education as one of the key sectors. The sector contains two Directorates Education and Vocational training. The formation of the sector and the allocations of the functions have been through key policy documents; the Constitution of Kenya 2010, the Fourth Schedule, Part 2 outlines specific responsibilities devolved to the county governments on pre-primary education, village polytechnics and Child Care facilities. The Government of Kenya has formulated several policies, Acts and regulations for education and vocational training. These include Pre-primary Education Policy 2017, Children's Act 2012, TVET Act 2013, Basic Education Act 2012, Public Finance Management (Nakuru County Bursary Fund) Regulations 2015 Section 4(II) which outlines, School Safety Manual, Subsidized Vocational Training Centre Support Grant Regulations, Ministry of Health COVID-19 Protocols, Public Health Act and ECDE Act 2021. The Directorate of Education has been working closely with the Kenya Institute of Curriculum Development and the Ministry of Education. The Directorate of Vocational Training has been working closely with the State Department for Vocational and Technical Training on the implementation of various policies and guidelines.

The Sector report takes a lead to interface strategy, planning and budgeting. This is anchored into programmes and prudent asset use, accountability and responsibility in the public resource allocation and expenditure. The sector budget proposal for the period 2022/23-2024/25 is being prepared under the Medium-Term Expenditure Frame (MTEF) and is programme based in line with the Public Finance Management Act (PFMA) 2012. This process gives way for the actualization of the final stretch of the County Integrated Development Plan (2018-2022) implementation.

The Directorate of Education has a total of 148 permanent staff (32 staff and 116 ECE Teachers) and 258 ECE teachers on contract (8 were affected by natural attrition). The enrolment of ECE children in the County currently stands at 117,090 i.e. Public ECE 52,485 (26,402 boys and 26,083 girls) and 64,605 (32,648 boys and 31,957 girls) in our private ECE centres. The teacher pupil ratio in public schools is 1:141 which goes against the policy of 1:30, hence the Directorate has a gap of 1,750 ECE teachers. The transition rate in ECE currently stands at 98%. The Directorate of Education currently has a total of 940 Public ECE attached to primary schools and 74 standalone ECE Centres. The infrastructure in ECE has improved since Early Childhood Education (ECE) was devolved. However, it is still inadequate hence the need for more budgetary allocations. The Directorate constructed 2 Centres of Excellence in Naivasha and Nakuru West Sub-county and distributed age appropriate furniture to all public ECE Centres as flagship projects. The Directorate of Vocational Training has 33 functional Vocational Training centres and ten others awaiting commissioning. The enrolment of trainees is 5321 (2,588 Male and 2,733 Female). It also has 130 instructors and 14 permanent members of staff. The ratio of instructors to trainees is 1:41 which is below the recommended standards by the Ministry of Education and Technical Vocational Education Training Authority (TVETA) of 1:20.

#### 1.2 Sector Vision and Mission

#### Vision

A globally competitive education, training, research and innovation system for sustainable development.

#### Mission

To provide, promote and coordinate quality education and training for lifelong learning and sustainable development.

#### 1.3 Strategic Goals/Objectives of the Sector

The sector is committed to the provision of quality education, training, science and technology to all residents of Nakuru through; -

- Development of policies and regulations to govern Vocational Training and Early Childhood Education (ECE) matters in the county.
- Provision of quality Pre-Primary education and Vocational Training
- Planning and Coordination of both Early Childhood Education (ECE) and Vocational Training
- Ensuring quality assurance and standards for all ECE centres and Vocational Training Centres programmes and activities.
- Enhancing access, retention and transition through provision of bursaries and scholarships to needy students of Nakuru County.
- Provision of conditional grant for rehabilitation of Vocational Training Centres.

#### 1.4 Sub Sectors and their Mandates

The sector has two Directorates i.e. Early Childhood Education (ECE) and Vocational Training.

The ECE Directorate undertakes the responsibility as stipulated in the Constitution of Kenya, which is the establishment of Pre-Primary education and promotion of

access to basic education in the County. The Directorate has 372 ECE teachers and 31 staff. The enrolment of ECE children currently stood at 117,090 as at 2020/21. The infrastructure within ECE centres has improved since devolution in 2013. The Sub Sector's mandate include:

- Provision ECE infrastructure and other facilities
- Provision of ECE Teachers
- Provision of ECE instructional materials
- Provision of Free and Compulsory Basic ECE as anchored in Basic Education
   Act 2012 and ECE Act 2021
- Capacity building of ECE teachers
- Coordination of all ECE curriculum and co-curricular activities
- Support of Early Childhood Nutrition and health through school feeding programme
- Monitoring and evaluation of ECE programmes
- ECE data management.
- Integration of ICT in ECE

The Directorate of Vocational Training undertakes its responsibility as stipulated in the Constitution of Kenya 2010, Schedule 4, Section 9 on County Government functions and the Governor's Executive Order of 2018 that moved Vocational Training from youth, culture, sports and social services to the Department of Education, ICT & e-Government. The directorate has 33 functional Vocational Training centers and 10 other Centers awaiting opening. The mandate of the directorate include: -

- Provision of vocational and technical training education.
- Provision of vocational and technical training facilities.
- Skill upgrading with the emerging issues in the curriculum
- Development of policies and regulations to govern Vocational Training

- Monitoring and evaluation of Vocational Training programs.
- Implementation of Vocational Training policies
- Provision of Vocational Training instructors and other staff

#### CHAPTER TWO

#### 2.0 PROGRAMME PERFORMANCE REVIEW FOR THE PERIOD 2018/2019-2020/21

# 2.1 Review of Sector Programmes/Sub-Programmes/Projects-Delivery of Outputs/ Key Performance Indicators (KPI)/Targets

The Directorate of Education prioritized the following programmes; construction of classrooms, establishment of 2 Centres of Excellence, procurement of ageappropriate furniture, recruitment of ECE teachers, improvement of sanitation in all ECE Centres and enhancement of transition and retention through provision of Bursary to needy students. During the period under review, the Directorate of Education constructed 509 ECE classrooms increasing facilities towards enhancing Early Childhood learning within the county. Increased awareness on importance of Early Childhood Education led to an increase in retention and transition rates. Language, Mathematics and Environmental Activity books were procured and distributed to all public ECE Centres. The Directorate is in the process of procuring Creative and Psychomotor for learners and ECE teacher Handbooks. It also procured age-appropriate furniture to ECE Centres and trained all ECE coordinators on Report Writing and Senior Management Course. The department recruited 372 ECE teachers on permanent basis. The Directorate constructed 2 No. ECE Centres of Excellence in Naivasha and Nakuru West Subcounties.

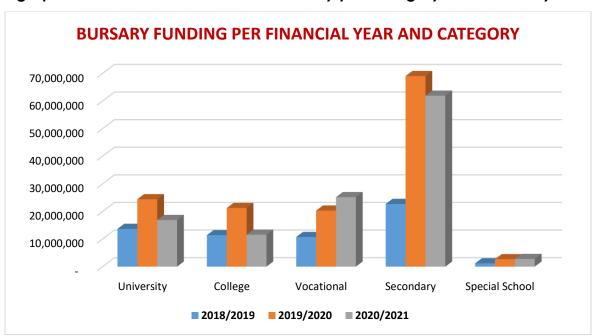
#### 2.1.1 Impact of Bursary Since Inception In FY 2013/2014

Secondary schools applicants benefitted up to 80% by bursary paid by the County Government of Nakuru. There was a huge relief to parents whose children were paid for. Applicants in driving schools benefitted greatly since most of them were able to acquire Driving Licenses hence improving livelihoods and enhancing road safety in Nakuru.

In a survey carried out by the ADHOC Committee on Bursary Evaluation Nakuru County, 85% of students' response indicated that in the County Bursary was very helpful towards their fee payment.

It is worth noting that majority of the County Bursary beneficiaries were in the Secondary category.

The Directorate of Education facilitated the rolling out of bursaries worth Kshs 334,433,355 benefiting 87,512 needy students in both Secondary and Tertiary Institutions across all the 55 wards during the period under review. Secondary schools benefitted with the largest share of 48%. Successful achievements of this initiative can be credited to the implementation of the policy governing the issuance of bursaries.

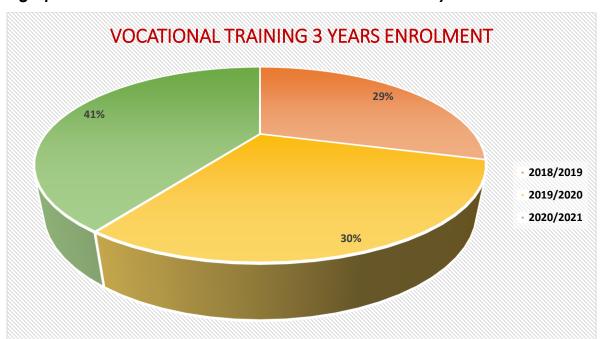


The graph below shows distribution of bursary per category for the last 3 years

The Directorate of Vocational Training had prioritized the following programmes; construction of training rooms, recruitment of instructors, procurement of tools and equipment and disbursement of Subsidized Vocational Training Support Grant to trainees (SVTSG). During the period under review, the Directorate of

Vocational Training recruited 22 instructors on permanent basis. It constructed 5 Vocational Training Centres spread across the County, 3 administration blocks and a Boys hostel at Dundori VTC. In the same period, the directorate procured tools and equipment worth Ksh 20 million benefiting 33 VTC's spread across the county. The Directorate provided 600 attachment places and supervision to trainees. It was also able to hold four sensitisation sessions across the county to popularize Vocational Training and the programmes offered. To increase access, retention and completion rate, the Directorate further disbursed Kshs 211M to 12,045 trainees as Subsidized Vocational Training Centres Support Grant. During the period under review the graduation rate stood at 31%

#### 3.2 Analysis of Resource Requirement versus Allocation by Sector:

#### 3.2.1 Sector Recurrent

The Table 5a shows a summary of the resource requirement versus the allocation as per Department projections. In order for the sector to achieve its mandates, the requirement are herein summary in the table below according to its economic classification. The main requirements are namely, contractual employees i.e.; ECE teachers and instructors. This is to enable the department hire 60 vocational training instructors and 350 ECE teachers to reduce the existing gap of 210 instructors and 1,750 ECE teachers. Purchase of learning materials to be in line with the new CBC in provision of free and compulsory Early Childhood Education to all public ECE's within our jurisdiction. The department has also made a requirement to cater for exit programme of Vocational Training Trainees. This will enable them be supplied with tools to start their trade as they graduate from Vocational Training. The Co-Curricular allocation will help trainees participate in drama, music and sports competitions for both ECE and Vocational Training.

It is a requirement that all public ECE Centers and Vocational Training Centers acquire Title Deeds to avoid land grabbers hence the need for the department to facilitate the process.

For the Department to achieve its target the ideal Gross Recurrent requirement for the period 2022/23 is **Kshs.** 1,050,297,946 against a ceiling of **Kshs.** 714,305,807, for the period 2023/2024 the Gross Recurrent requirement is **Kshs.** 1,266,492,361 against an allocation of **Kshs.** 788,736,387 and **Kshs.** 1,539,124,421as the Gross Recurrent requirement against an allocation of **Kshs.** 864,310,025 for the period 2024/2025.

#### CHAPTER FIVE

#### **5.0 EMERGING ISSUES AND CHALLENGES**

The Education Sector has unique operations, emerging issues and challenges as stated below;

## 5.1 Emerging Issues

- COVID-19 pandemic
- Implementation of Competency Based Curriculum (CBC);
- The review of legal and policy framework that guides ECD;
- Government policy on 100% transition on all levels;
- Unstructured mushrooming of unregistered ECDE centres and vocational centres which compromises on quality and standard of training.
- Implementation of Competency Based Education and Training (CBET) for Vocational Training Instructors

# **5.2 Challenges**

There is high expectation from the public who want to be given quality services in Early Childhood Education Centres and Vocational Training. This has at times resulted in the public feeling disappointed when their requests and expectations are not met.

The following are the challenges facing the sector: -

- Insufficient and ever reducing funding, coupled with delay in disbursement of funds which hampers implementation of projects and programmes;
- Insufficient allocation for the construction of ECD classroom and water point;
- Political interference in the disbursement of Bursary;
- Inadequate transport in the sector at all levels that hinders monitoring and evaluation;

- ECD and Vocational Training follow an Education calendar while the county follows financial year calendar which does not match with timely release of funds;
- Frequent revision of the budget even after the expenditure has been committed greatly affect the implementation of programmes;
- Inadequate capacity building programmes e.g. for teachers and instructors which affects career progression;
- Inadequate human resources, insufficient office space and furniture;
- Lengthy procurement process and procedures which delay service delivery;
- Minimal input from stakeholders especially on ECDE activities;
- ECDE and VTC's classrooms put up without the accompanying requirements e.g. furniture, qualified instructors and sanitary facilities.
- Negative perception of vocational training centres hence low enrolment
- Misconception of VTCs subsidized grant that the training is totally free,
   which is not the case.
- COVID-19 pandemic has posed a very big challenge to both ECDE and Vocational Training Centres. In order to comply with the COVID-19 protocols the following will be needed:
  - i.) Extra training rooms and classes for social distancing.
  - ii.) More teachers and instructors to take care of the new rooms created.
  - iii.) More training materials and equipment to ensure no sharing.
  - iv.) Provision of thermo guns, face masks, sanitizers and hand-washing points for both learners and instructors /teachers.

## 5.3 Lessons learnt

- i.) Analysis of projects evaluated revealed that there was higher efficiency in project implementation in cases where there was collaboration between sectors. This contributed to achievement of higher-level outcomes in projects/programmes interventions.
- ii.) Projects/programmes implemented through National donors/Local partnerships demonstrated better progress compared with direct departmental initiatives.
- iii.) Regular field monitoring and evaluation is important in collection of data necessary for decision making, tracking, implementation in development planning and advising future projects planning and design.
- iv.) The emergence of COVID-19 pandemic has had disruptive effects to sector operations, academic calendar, businesses and livelihoods. This is expected to have lasting effects beyond the CIDP 2018-2022 implementation period

#### **CHAPTER SIX**

## 6.0 CONCLUSION

In conclusion, it is worth noting that the sector plays a critical role in County development as all plans and programmes are linked with educational foundation.

In view of this, the sector is committed to lead in performance in both Early Childhood Education and Vocational Training. Towards this commitment, the sector requires sufficient and timely release of funds as approved in the budget. This will enhance the development projects that meet the requirements of Vision 2030 and attainment of the Government Big 4 Agenda as well as realising the county's manifesto.

Most of the projects in this sector are on-going and a substantial amount has been spent on them and they still need more funds to complete them. The sector also wants to undertake new projects in line with fulfilling its mandate. Fully equipped 4 Hostels are among the new projects the sector wants to undertake, the design and construction of 10 Libraries which are to be constructed in the Centres of Excellence other Training Centres. The estimated cost of the construction of 4 Hostels is 60M (15M each) while the construction of the 10 Libraries is 250M (25M each). The setting up of ECE's Model Centres are estimated to cost Kshs.10 Million. The Directorate of Education intends to have nine ECE Centres of Excellence, that is, one in every Sub-county. In the FY 2019/2020 the Directorate constructed two Centres of Excellence in Naivasha Sub County at Millimani ECD centre and Nakuru West Sub County at Muslim ECD centre at a cost of Kshs. 20,000,000. In order to comply with COVID-19 regulations, the sector need to put up more infrastructure, estimated to cost about Kshs. 300 Million.

However, the sector has continued to receive low budgetary allocations and in turn affecting the implementation of the sector Recurrent and Development Programmes. The Sector request for addition budgetary allocations. Also, quick releases from the Exchequer will help the Sector and the County at large in realising their stated objectives and mandate.

In view of the stated budgeted budgetary challenges, the sector will endeavour to bring on board development partners like JICA, AKIRA/ILO, and Child fund Kenya, Commercial banks, book publishers among others to partner with the Sector to bridge the existing gaps. The Sector will also prioritise its projects for effective utilisation to the funds allocated to it.

## **CHAPTER SEVEN**

#### 7.0 RECOMMENDATIONS

In view of challenges and emerging issues the sector recommends the following measures to enhance delivery of quality Education and Training Service to the public and for effective implementation of the Flagship Projects and other programmes

- Increase the ceilings that are too low, which affects the implementation of the various programs and projects.
- Timely release of funds by the treasury to enable the sector run its programmes. The county treasury should consider allocating funds to the prioritised programmes in order to speed up service delivery.
- Increase the allocation for construction of an ECD classroom and water point from 1.2M to 1.5M
- Review Policy on disbursement of Bursary to ensure a free and fair process
- Timely development of Bill of Quantities.
- Provision of Sector operational vehicles
- Construction of one Model ECD Centre per Sub-County.
- Construction of a County Model Polytechnic that will offer training up to Higher National Diploma and collaborate with universities to offer bachelors in technical courses like engineering.
- Set up one Vocational Centre of Excellence in each Sub-County.
- Provision of funds to mitigate the COVID-19 pandemic.
