## MIN 2: BACKGROUND OF FREE AREA STAGES

A member presented a brief background of the existing Free Area tuktuk stages, namely:

1. Upper Menengai Riders
2. Free Area Riders
3. Madaraka
4. Jet East
5. Nakuliners
6. Wakulima
7. Divine
8. Tangatanga

## MIN 3.: Challenges

Members outlined several challenges experienced in their daily operations, including:

- Influx of tuktuks, resulting in inadequate stage space for new riders.
- Picking up passengers in non-designated areas, leading to disorderliness.
- Obstruction and lack of proper management, resulting in:
  - Loss of revenue
  - Cases of indiscipline
  - Division among tuktuk riders
  - Negative impact on most riders

## MIN 4: Way forward

The leaders resolved to ensure proper and efficient management of Free Area tuktuks through the following measures:


1. Reorganize the stages by establishing a main stage at a strategic location, which will serve as the primary stage and the last stop before entering the CBD.
2. Riders will be permitted to operate from the other stages below the main stage as shall be established.
3. The current stage leaders shall form an interim leadership committee, with Tangatanga represented in this leadership. The County Tuktuk Chairperson will oversee this arrangement.
4. The County Tuktuk leadership will manage the transition and ensure all members are duly informed.
5. New members must register with the Sub-County Office for management purposes.
6. Following these resolutions, all Free Area tuktuks shall operate under one unified leadership.

7. No passengers shall be carried from the main stage to Menengai High School. Passengers within that vicinity must use the designated lower stages.
8. Tuktuks ferrying goods shall not be affected by these resolutions.
9. The main stage shall be located at the junction of Legacy Hotel and East Road.

The members present appended their signatures as confirmation and agreement to the above resolutions.
