**REPORT ON CONSULTATIVE FORUM BETWEEN NAKURU CREATIVES AND
THE CITY MANAGER ON 21ST MAY 2025**

1. Introduction

This report follows a consultative forum held between creatives from Nakuru City and the City Manager, Mr. Gitau Thabanja, aimed at strengthening coordination, structured support, and sustainable growth of the creative sector.

The engagement reflects Nakuru's continued commitment to nurturing its creative economy and positioning itself as a leading hub for arts and culture in Kenya and the region.

2. Key Deliberations and Outcomes

a) Formation of Nakuru Thespian Guild

A major milestone from the meeting was the formal formation of the Nakuru Thespian Guild. The Guild was constituted with a relevant and structured office leadership framework to ensure accountability, coordination, and representation of theatre practitioners within the county. The office structure includes key leadership positions responsible for governance, programming, membership coordination, finance, and partnerships.

The Guild will:

- Coordinate theatre practitioners across sub-counties.
- Provide structured representation of performing artists.
- Advocate for policy support and improved working conditions.
- Support capacity building and professional development.

This marks a significant step toward formalizing the performing arts ecosystem in Nakuru

b) Trainer of Trainers (ToT) Model

The meeting proposed the adoption of a Trainer of Trainers (ToT) model where experienced creatives will mentor emerging artists across sub-counties.

The model aims to:

- i. Identify and nurture untapped talent.
- ii. Build technical and leadership capacity.
- iii. Ensure sustainability through skills transfer.
- iv. Prepare future creative leaders within the county.

c) Permit Challenges for School Performances

Concerns were raised regarding the lengthy process of acquiring permits for school performances, particularly for groups staging set books.

Creatives requested:

- i. Streamlined approval processes.
- ii. Clear timelines and guidelines.
- iii. Improved coordination between relevant departments.

d) Sustainable Income and Access to Funding

Creatives emphasized the need to transition from passion-driven practice to sustainable enterprise.

To address this, they proposed forming a SACCO/Association to:

- i. Pool resources collectively.
- ii. Access affordable loans.
- iii. Strengthen financial discipline.
- iv. Enhance business and entrepreneurial skills.

3. Commitments by the City Manager

Mr. Gitau Thabanja pledged support in the following areas:

- i. Access to public venues for rehearsals and performances.
- ii. Facilitation of capacity-building trainings.
- iii. Inclusion of creatives in county planning frameworks.
- iv. Support for the establishment of a shared bus to ease transportation for performances and events.

The City Manager reiterated the commitment of H.E. Governor Susan Kihika to strengthening the creative economy, recognizing its role in youth empowerment, employment creation, and cultural development.

4. Recommendations

1. Support formal registration and operationalization of the Nakuru Thespian Guild.
2. Develop an implementation framework for the Trainer of Trainers model.
3. Engage relevant departments to review and simplify permit procedures.
4. Facilitate guidance for establishing the proposed SACCO/Association.
5. Develop a concept note for the shared bus initiative.

5. Conclusion

The consultative forum held on 21st May 2025 demonstrated renewed unity and structured organization within Nakuru's creative sector. The formation of the Nakuru Thespian Guild represents a major milestone toward institutional strengthening of the performing arts.

With continued collaboration between creatives and the city administration, Nakuru is well positioned to advance its creative economy and enhance opportunities for artists across the county.


