**EXECUTIVE ORDER NO. 6 of 2021**

**To All Whom These Presents Shall Come**

**WHEREAS**, Article 184 of the Constitution Mandates Parliament to enact legislation to provide, inter alia, the criteria for classifying areas as cities and establishing the principles of governance and management of cities;

**WHEREAS**, Parliament enacted the Urban Areas and Cities Act in furtherance of Article 184 of the Constitution, and the Urban Areas and Cities Act received presidential assent on 27<sup>th</sup> August, 2011;

**WHEREAS**, the People of Nakuru County were desirous of having the Municipal Council of Nakuru upgraded to the



status of a City, they, through the Municipality, the County Executive Committee, and the County Assembly of Nakuru placed on record their desire; and the same was approved by the Municipality, the County Executive Committee, and the County Assembly; and was thereafter placed before the Senate;


**AND WHEREAS** the Senate, having satisfied itself that all legal criteria had been satisfied and it was fit and proper that the Municipal Council of Nakuru be upgraded to a city; on **3<sup>rd</sup> June 2021** the Senate by affirmative resolution gave its approval to the application and recommendation that the Municipal Council of Nakuru be conferred with city status.

**NOW THEREFORE**, in exercise of the powers conferred on the Head of State and Government under Section 7 of the Urban Areas and Cities Act (Act No. 13 of 2011) and all other enabling provisions of law, I, **UHURU KENYATTA**, President of the Republic of Kenya and Commander in Chief of the Kenya Defense Forces, **DO HEREBY CONFER** City Status to the Nakuru Municipality.



**NOW HENCEFORTH**, may it be known by all persons and authorities that the Nakuru Municipality is to be known as **THE CITY OF NAKURU**, and **THE CITY OF NAKURU** shall therefore have all the powers, authority, rank, and privileges of a city under the Laws of Kenya; and it shall have all the rights, duties, and standing of a city provided for under the Urban Areas and Cities Act and all other applicable Laws.

**ISSUED** under **the HAND AND SEAL** of the President of the Republic Kenya on this **FIRST** Day of **DECEMBER**, the year of our **LORD TWO THOUSAND AND TWENTY-ONE**.
