Market representatives raised concerns regarding stalled construction works, poor drainage, muddy conditions, inadequate sheds, and insecurity.

Community representatives highlighted challenges related to solid waste management, illegal dumping, roaming livestock, blocked drainage, water shortages, poor road infrastructure, lack of street lighting, tenure regularization delays, and environmental health risks.

Civil society and government agencies addressed gender-based violence response mechanisms, environmental conservation, disaster preparedness, and the need for coordinated stakeholder engagement.

Contractor representatives emphasized the importance of project supervision, engagement of local contractors, and structured contractor forums.

These include construction of parking facilities, non-motorized transport infrastructure, and market facilities. He noted that solid waste management remains a major challenge due to limited financial resources and emphasized the need for partnerships and collaboration.</p> <p>The Chairman Gilgil Municipal Board The Chairman of the Board outlined the governance structure of the Municipal Board, its committees, and the role of the municipal secretariat. He informed the meeting that the municipal charter was gazetted on 7th July 2022 and highlighted priority capital development projects including non-motorized transport systems, drainage improvements, market construction, Jua Kali shades, and rehabilitation of social facilities.</p>	<p>The presentation was noted</p> <p>The presentation was noted</p>

He further noted that municipal funding is largely dependent on exchequer allocations, which remain inadequate, and encouraged partnerships to support sustainable municipal development

Mr George Wesonga – Council of governors

The representative from the Council of Governors confirmed that the Municipal Board is properly constituted in accordance with the Urban Areas and Cities Act (Amendment) 2019. He emphasized the importance of developing municipal by-laws and adhering to principles of public participation, including inclusivity, transparency, and feedback mechanisms. He encouraged residents to form and register neighborhood associations and organized groups to enhance structured engagement with the municipality.
